**Regolamenti ta' l-2003 li Jistabbilixxu Penali u Sanzjonijiet  
Amministrattivi dwar l-Għaqdiet Koperativi**

BIS-SAHHA tas-setghat moghtija bl-artikoli 17 u 108 ta' l-Att dwar l-Għaqdiet Koperativi, il-Viči Prim Ministro u Ministro ghall-Politika Soċjali għamel dawn ir-regolamenti li ġejjin:—

**1.** It-titolu ta' dawn ir-regolamenti hu Regolamenti ta' l-2003 li Jistabbilixxu Penali u Sanzjonijiet Amministrattivi dwar l-Għaqdiet Koperativi, u għandhom jibdew isehhu f'dik id-data li l-Ministro responsabbi għall-affarijiet li għandhom x'jaqsmu mas-soċjetajiet koperativi jista' b'avviż fil-Gazzetta jistabbilixxi. Jistgħu ukoll jiġu stabbiliti dati differenti għad-dħul fis-sehh ta' għanijiet differenti u disposizzjonijiet differenti ta' dawn ir-regolamenti.

**4.** Il-Bord ikollu wkoll is-setgha li jxandar fil-gazzetti ta' kuljum u fuq il-mezzi tax-xandir l-ismijiet ta' dawk l-ghaqdiet koperattivi li jkunu saru soġġetti għal penali u sanzjonijiet amministrattivi mill-istess Bord skond ma hemm provdut f'dawn ir-regolamenti u fl-Att:

**5. (1)** L-ghemil ta' proċeduri għall-użu u l-applikazzjoni ta' penali u sanzjonijiet amministrattivi mill-Bord għar-rigward ta' xi kontravvenzjoni kif tidher f'dawn ir-regolamenti jipprekludi milli jsiru proċeduri kriminali fil-konfront ta' l-istess persuna dwar l-istess kontravvenzjoni. **Prekluzjoni ta'  
proċeduri doppi.**

(2) Id-dispożizzjonijiet ta' dawn ir-regolamenti ma japplikawx f'dawk il-każijiet fejn jittieħdu proċeduri kriminali dwar xi kontravvenzjoni imsemmija fl-Iskeda li tinsab ma' dawn ir-regolamenti.

**CO-OPERATIVE SOCIETIES ACT  
(CAP. 442)**

**Co-operative Societies (Establishment of Administrative Penalties and Sanctions) Regulations, 2003.**

IN exercise of the powers conferred by articles 17 and 108 of the Co-operative Societies Act, the Deputy Prime Minister and Minister for Social Policy has made the following regulations:-

Citation and commencement.

**1.** The title of these regulations is the Co-operative Societies (Establishment of Administrative Penalties and Sanctions) Regulations, 2003, and they shall come into force on such date as the Minister responsible for matters relating to co-operative societies may by notice in the Gazette establish. Different dates may be so established for the coming into force of different purposes and different provisions of these regulations.

Definitions.

**2.** Words used in these regulations shall have the same meaning as in the Co-operative Societies Act, hereinafter referred to as "the Act".

Power to impose administrative penalties and sanctions.

**3.** The Board shall have the power to impose administrative penalties and sanctions in accordance with the Schedule to these regulations.

Authority to publicize.

**4.** The Board shall also have the authority to publish in daily newspapers and in the broadcasting media the names of those co-operative societies which have become subject to administrative penalties and sanctions imposed on them by the same Board as provided for in these regulations and in the Act:

Provided that the Board shall use this authority only to give public notice of such contravention, and during such time as the said contravention persists.

Preclusion of dual proceedings.

**5. (1)** The taking of proceedings for the use and application of administrative penalties and sanctions by the Board with respect to a contravention as outlined in these regulations shall preclude the taking of criminal proceedings against the same person in respect of the same contravention.

(2) The provisions of these regulations shall not apply in those cases where criminal proceedings are commenced in respect of a contravention included in the Schedule to these regulations.

The Board may take for any person who has violated any of the articles of the Act or of any regulations made thereunder as listed in the first column of this Schedule, the corresponding penalties listed in the third and fourth columns of this Schedule:
