1. Dawn ir-regolamenti jistgħu jissejhu r-Regolamenti ta' l-2003 biex jemendaw ir-Regolamenti tal-Kors għall-Grad ta' Bachelor of Arts (Tourism Studies) - B.A. (Tourism Studies) - u Bachelor of Arts (Honours) (Tourism Studies) - B.A. (Hons) (Tourism Studies) - u għandhom jinqraw u jinftiehmu bhala haġa wahda mar-Regolamenti ta' l-2002 tal-Kors għall-Grad ta' Bachelor of Arts (Tourism Studies) - B.A. (Tourism Studies) - u Bachelor of Arts (Honours) (Tourism Studies) - B.A. (Hons) (Tourism Studies) - ippublikati bhala Avviż Legali 306 ta' l-2002, li minn hawn 'il quddiem jissejhu "ir-regolamenti prinċipali".

Applikabilita'

2. Dawn ir-regolamenti għandhom japplikaw għall-korsijiet li bdew f'Ottubru 2001 jew wara.

Żieda tal-paragrafu (8) mar-regolament 9 tar-regolamenti prinċipali

3. Il-paragrafu (8) li ġej għandu jiżdied wara l-paragrafu (7) tar-regolament 9 tar-regolamenti prinċipali:

"(8) It-taqsimiet studju li jittieħdu flimkien ma' l-studenti tal-Bachelor of Commerce għandhom ikunu valutati skond il-kriterji stabbiliti għall-kors tal-Bachelor of Commerce."

**EDUCATION ACT
(CAP. 327)**

**Bachelor of Arts (Tourism Studies) - B.A. (Tourism Studies) - and
Bachelor of Arts (Honours) (Tourism Studies) - B.A. (Hons) (Tourism Studies) -
Degree Course (Amendment) Regulations, 2003**

IN exercise of the powers conferred upon him by sections 30 (5) and 31 (6) of the Education Act (Cap. 327), the Chancellor of the University of Malta has promulgated the following regulations made by the Senate of the University of Malta by virtue of the powers conferred upon it by sections 31 and 35 of the said Act:

Citation

1. These regulations may be cited as the Bachelor of Arts (Tourism Studies) - B.A. (Tourism Studies) - and Bachelor of Arts (Honours) (Tourism Studies) - B.A. (Hons) (Tourism Studies) - Degree Course (Amendment) Regulations, 2003 and shall be read and construed as one with the Bachelor of Arts (Tourism Studies) - B.A. (Tourism Studies) - and Bachelor of Arts (Honours) (Tourism Studies) - B.A. (Hons) (Tourism Studies) - Degree Course Regulations, 2002, published as Legal Notice 306/2002.

Applicability

2. These regulations shall be applicable for courses starting in October 2001 or later.

Addition of paragraph (8) to regulation 9 of the principal regulations

3. The following paragraph (8) shall be added after paragraph (7) of regulation 9 of the principal regulations:

“(8) The study-units taken in common with the Bachelor of Commerce students shall be assessed according to the criteria established for the Bachelor of Commerce course.”
