**ATT DWAR L-EDUKAZZJONI
(KAP. 327)**

Ir-Regolamenti ta' l-2003 biex jemendaw ir-Regolamenti tal-Kors għas-Certificate in Foundation Studies

BIS-SAHHA tas-setgħat mogħtija lilu bl-artikoli 30 (5) u 31 (6) ta' l-Att dwar l-Edukazzjoni (Kap. 327), il-Kanċillier ta' l-Universita' ta' Malta ppromulga dawn ir-regolamenti magħmula mis-Senat ta' l-Universita' ta' Malta bis-saħħha tas-setgħat mogħtija lilu bl-artikoli 31 u 35 ta' dak l-Att:

Titolu

1. Dawn ir-regolamenti jistgħu jisseqjh r-Regolamenti ta' l-2003 biex jemendaw ir-Regolamenti tal-Kors għas-Certificate in Foundation Studies u għandhom jinqraw u jinfieħmu bħala ħażja mar-Regolamenti tas-sena 2000 tal-Kors għas-Certificate in Foundation Studies, ippubblikati bħala Avviż Legali 192 ta' l-2000, li minn hawn 'il quddiem jisseqjh “ir-regolamenti prinċipali”.

Applikabilità

2. Dawn ir-regolamenti għandhom jaapplikaw għall-korsijiet li jibdew f'Ottubru 2003 jew wara.

Emenda għar-regolament 4 tar-regolamenti prinċipali

3. Minflok ir-regolament 4 tar-regolamenti principali għandu jidħol dan li ġej:

“4. Il-Kors huwa miftuħ biss għall-applikanti barranin li:

B 840

- (a) jkunu temmew l-edukazzjoni sekondarja u/jew l-iskola għolja barra; u
- (b) jkollhom waħda mill-kwalifikasi fl-Ingliz li ġejjin fil-livell meħtieg:
 - (i) Test of English as a Foreign Language (TOEFL) 500 jew 173 CB;
 - (ii) International English Language Testing System 5.5;
 - (iii) Cambridge First Certificate bi grad Ċ jew aħjar; jew xi kwalifika ekwivalenti oħra approvata mill-Bord; u
- (c) jkollhom kwalifikasi li jagħtu aċċess għal edukazzjoni għolja fil-pajjiż fejn inkisbu dawn il-kwalifikasi; iżda
- (d) huma meqjusa li għandhom bżonn aktar studju qabel ma jidħlu f'korsijsiet li jwasslu għal grad fl-Universita' ta' Malta.”

**EDUCATION ACT
(CAP. 327)**

Certificate in Foundation Studies Course (Amendment) Regulations, 2003

IN exercise of the powers conferred upon him by sections 30 (5) and 31 (6) of the Education Act (Cap. 327), the Chancellor of the University of Malta has promulgated the following regulations made by the Senate of the University of Malta by virtue of the powers conferred upon it by sections 31 and 35 of the said Act:

Citation

1. These regulations may be cited as the Certificate in Foundation Studies Course (Amendment) Regulations, 2003 and shall be read and construed as one with the Certificate in Foundation Studies Course Regulations, 2000, published as Legal Notice 192 of 2000, hereinafter referred to as "the principal regulations".

Applicability

2. These regulations shall be applicable for courses starting in October 2003 or later.

Amendment of regulation 4 of the principal regulations

3. For regulation 4 of the principal regulations there shall be substituted the following:

"4. The Course is open only to overseas applicants who:

(a) have completed their secondary and/or high school education abroad; and

(b) are in possession of one of the following qualifications in English at the required level:

- (i) Test of English as a Foreign Language (TOEFL) 500 or 173 CB;
 - (ii) International English Language Testing System 5.5;
 - (iii) Cambridge First Certificate at grade C or better;
- or any other equivalent qualification approved by the Board; and
- (c) are in possession of qualifications allowing access to higher education in the country where such qualifications were obtained; but
 - (d) are deemed to require further study to be admitted to degree courses at the University of Malta."
