**Ir-Regolamenti ta' l-2003 biex jemendaw ir-Regolamenti tal-Kors għad-Diploma in Political Studies - Dip. Pol. St.**

BIS-SAĦHA tas-setgħat mogħtija lilu bl-artikoli 30 (5) u 31 (6) ta' l-Att dwar l-Edukazzjoni (Kap. 327), il-Kanċillier ta' l-Universita' ta' Malta ppromulga dawn ir-regolamenti magħmulu mis-Senat ta' l-Universita' ta' Malta bis-saħħha tas-setgħat mogħtija lilu bl-artikoli 31 u 35 ta' dak l-Att:

**Titolu**

1. Dawn ir-regolamenti jistgħu jisseqjh u r-Regolamenti ta' l-2003 biex jemendaw ir-Regolamenti tal-Kors għad-Diploma in Political Studies - Dip. Pol. St. - u għandhom jinqraw u jinftieħmu bħala ġaġa waħda mar-Regolamenti ta' l-1998 tal-Kors għad-Diploma in Political Studies - Dip. Pol. St. - ippubblikati bħala Avviż Legali 49 ta' l-1998, li minn hawn 'il quddiem jisseqjh "ir-regolamenti prinċipali".

**Applikabilità**

2. Dawn ir-regolamenti għandhom jaapplikaw ghall-korsiċċiet li jibdew f-Ottubru 2002 jew wara.

**Emenda għar-regolament 7 tar-regolamenti prinċipali**

3. Minflok il-paragrafu (1) tar-regolament 7 tar-regolamenti prinċipali għandu jidħol dan li ġej:

**B 848**

“7. (1) Kull student għandu jkun meħtieġ jikteb Essay ta’ madwar 5,000 kelma, li għaliex tliet krediti huma assenjati, fuq suġġett approvat maħsub biex juri kemm l-student hu kapaċi jintegra d-diversi aspetti tal-kors ta’ studju.”

**EDUCATION ACT  
(CAP. 327)**

**Diploma in Political Studies - Dip. Pol. St. - Course (Amendment) Regulations,  
2003**

IN exercise of the powers conferred upon him by sections 30 (5) and 31 (6) of the Education Act (Cap. 327), the Chancellor of the University of Malta has promulgated the following regulations made by the Senate of the University of Malta by virtue of the powers conferred upon it by sections 31 and 35 of the said Act:

**Citation**

1. These regulations may be cited as the Diploma in Political Studies - Dip. Pol. St. - Course (Amendment) Regulations, 2003 and shall be read and construed as one with the Diploma in Political Studies - Dip. Pol. St. - Course Regulations, 1998, published as Legal Notice 49 of 1998 hereinafter referred to as "the principal regulations".

**Applicability**

2. These regulations shall be applicable to courses commencing in October 2002 or later.

**Amendment of regulation 7 of the principal regulations**

3. For paragraph (1) of regulation 7 of the principal regulations there shall be substituted the following:

**B 850**

"7. (1) Each student shall be required to write an Essay of approximately 5,000 words, for which three credits shall be assigned, on an approved topic intended to illustrate the student's ability to integrate the various aspects of the course of studies."
