**ORDINANZA DWAR IL-HADDIEMA TAL-PORT
(KAP. 171)**

**Regolamenti ta' l-2003 li jemendaw ir-Regolamenti
dwar il-Haddiema tal-Port**

BIS-SAHHA tas-setghat moghtija bl-artikoli 16 u 17 ta' l-Ordinanza dwar il-Haddiema tal-Port, il-Ministru ghat-Trasport u Komunikazzjoni, f'konsultazzjoni ma' l-Awtorita' Marittima ta' Malta u bi ftehim mal-Ministru tal-Finanzi ghamel dawn ir-regolamenti li ġejjin:-

1. It-titolu ta' dawn ir-regolamenti Regolamenti ta' l-2003 li jemendaw ir-Regolamenti dwar il-Haddiema tal-Port, u ghandhom jinqraw u jiftiehmha haġa wahda mar-Regolamenti ta' l-1993 li jemendaw ir-Regolamenti dwar il-Haddiema tal-Port, hawn iżjed 'il quddiem imsejjha "ir-regolamenti prinċipali", u ghandhom jidhlu fis-sehh f'dak il-jum li l-Ministru jista' b'avviz jordna fil-Gazzetta.

Titolu u bidu fis-sehh.

2. Minflok ir-regolament 43 tar-regolamenti prinċipali ghandu jidhol dan li ġejj:-

Jissostitwixxi r-regolament 43 tar-regolamenti prinċipali.

"43. (1) Haddiem tal-port li jkun haddiem tal-port registrat fid-data tad-dhul fis-sehh ta' dan ir-regolament, jew f'xi data wara, ghandu jircievi gratwita' ghar-rigward ta' kull sena servizz, jew parti minnha, li ghandha tiġi kalkolata mill-4 ta' April 1973.

(2) Il-Ministru, wara li jikkonsulta lill-Kumitat, jista' għall-fini ta' dan ir-regolament, jawtorizza li ammonti tal-bidu u ta' kull sena jiġu investiti għand Kumpannija ta' l-Assigurazzjoni li jkollha riputazzjoni tajba bil-ghan li jinghataw dawk il-gratwitajiet lill-haddiema tal-port.

(3) Il-hlas ta' dik il-gratwita' ghandu jsir mill-Kumitat f'xi wahda minn dawn iċ-ċirkostanzi li ġejjin:-

(i) lil haddiem tal-port li jilhaq l-eta' tal-pensjoni, jew

(ii) lil haddiem tal-port li jkollu r-registrazzjoni tieghu imhassra mid-Direttur, jew

(iii) lill-werrieta ta' haddiem tal-port li jmut filwaqt li huwa jkun hekk registrat."

**PORT WORKERS ORDINANCE
(CAP. 171)**

Port Workers (Amendment) Regulations, 2003

IN exercise of the powers conferred by articles 16 and 17 of the Port Workers Ordinance, the Minister for Transport and Communications in consultation with the Malta Maritime Authority and in concurrence with the Minister of Finance has made the following regulations:-

Citation and commencement.

L.N. 90 of 1993.

Substitutes regulation 43 of the principal regulations.

1. The title of these regulations is the Port Workers (Amendment) Regulations, 2003 and they shall be read and construed as one with the Port Workers Regulations, 1993, hereinafter referred to as “the principal regulations”, and shall come into force on such day as the Minister may by notice prescribe in the Gazette.

2. For regulation 43 of the principal regulations there shall be substituted the following:-

“43. (1) A port worker who is a registered port worker on the date of the coming into force of this regulation, or subsequently, shall receive a gratuity in respect of each year of service, or part thereof, to be reckoned as from the 4th April 1973.

(2) The Minister, after consultation with the Committee, may for the purpose of this regulation, authorise that initial and yearly amounts be invested with a reputable Assurance Company for the purpose of the provision of such gratuities to port workers.

(3) The payment of the said gratuity shall be made by the Committee in any one of the following circumstances:-

- (i) to a port worker who reaches retirement age, or
- (ii) to a port worker whose registration is cancelled by the Director, or
- (iii) to the heirs of a port worker who dies whilst being so registered.”.
