- (a) fil-paragrafi (1) u (2) l-kliem “Kummissarju tal-Pulizija” għandhom ikunu mibdula bil-kliem “l-Awtorita’ dwar it-Trasport ta’ Malta”;
- (b) fil-paragrafu (4) l-kliem “f kull żmien liċenza mahruġa mill-imsemmi Kummissarju:” għandhom ikunu mibdula bil-kliem “f kull żmien liċenza mahruġa mill-imsemmija Awtorita:” u l-kliem “jgharraf bil-miktub lill-imsemmi Kummissarju” għandhom ikunu mibdula bil-kliem “jgharraf bil-miktub ill-imsemmija Awtorita” u l-kliem “l-imsemmi sid jikkonsejha lill-imsemmi Kummissarju” għandhom ikunu mibdula bil-kliem “l-imsemmi sid jikkonsejha lill-imsemmija Awtorita”;
- (c) fil-paragrafa (5) l-kliem ‘il-Kummissarju tal-Pulizija jista’ jneħhi dik il-vettura u jqiegħda fil-garage tal-Pulizija għas-spejjeż ta’ sidha.” għandhom ikunu mibdula bil-kliem “il-Kummissarju tal-Pulizija jew l-Awtorita’ dwar it-Trasport ta’ Malta, skond il-kaž, jistgħu jnejha dik il-vettura u jqiegħduha fil-garage tal-Pulizija jew f’xi post magħluq u sigur iehor għas-spejjeż ta’ sidha.”;

- Emenda għar-regolament 19 tar-regolamenti principali
6. Fir-regolament 20 tar-regolamenti principali l-kliem “l-Att dwar Awtorita” dwar it-Trasport Pubbliku.” għandhom ikunu mibdula bil-kliem “l-Att dwar l-Awtorita” dwar it-Trasport ta’ Malta.”

7. Regolament 65 tar-regolamenti principali għandu jkun mhassar u mibdul bir-regolament ġdid li ġej –
- “65. (1) L-ebda persuna ma’ tista tagħmilha ta’ *car park attendant* mingħajr liċenzja mahruġa mill-Awtorita’ dwar it-Trasport ta’ Malta.
- (2) Applikazzjoni ghall-liċenzja taht dan ir-regolament għandha issir fil-forma preskritta. L-formola mimlja, flimkien ma’ żewġ ritratti riċenti tal-applikant ta’ daqs kif użat ghall-passaport, għandha tkun iddepozitata jew mibghuta lill-uffiċċji tal-Awtorita’ dwar it-Trasport ta’ Malta.
- (3) Liċenzi ġodda ikunu mahruġa mill-Awtorita’ dwar it-Trasport ta’ Malta skond l-ordni ta’ priorita li fiha tkun rċeviethom l-imsemmija Awtorita’.

(4) Ličenzja mahruga taht dan ir-regolament għandha tkun:-

- (a) personali u mhux trasferibbli;
- (b) applikabbi biss ghall-hinijiet u post ta' parkegg skedat li l-*car park attendant* huwa illiċenzjat sabiex jissorvelja;
- (c) valida sal-31 ta' Diċembru tas-sena li fiha tkun mahruga, iżda tista minn hemm 'I quddiem tkun mġedda minn sena għal sena; u
- (d) sogġett ghall-ħlas ta' Lm5 pagabbli mal-ħruġ tal-licenzja u kull sena mid-data ta' ħruġ tal-licenzja.

L-Awtorita' dwar it-Trasport ta' Malta għandha ukoll tipprovdi lill-*car park attendants* b'tag ta' identifikazzjoni li tindika l-isem, in-numru tal-karta ta' identità u n-numru tal-licenzja, l-parkegg tal-karozzi li huwa illiċenzjat sabiex jissorvelja u l-hinijiet li matulhom jista jaġixxi bhala *car park attendant* f'dak il-parkegg tal-karozzi.

(5) L-ebda persuna lliċenzjata ma' tista taġixxi bhala *car park attendant* jekk ma' tkunx halset l-miżata tal-licenzja pagabbli kull sena jew ghall-perjodu kif speċifikat.

(6) L-Awtorita' dwar it-Trasport ta' Malta m'għandhiex toħroġ lill-ebda persuna liċenzja taht dan ir-regolament kemm-il darba ma' tkunx sodisfatta li l-persuna hija ta' kondotta tajba u li tkun kapaċi li taqdi d-dmirijiet tagħha.

(7) *Car park attendant* għandu, waqt ix-xogħol, jilbes t-tagħ ta' identifikazzjoni mahruga lilu mill-Awtorita' dwar it-Trasport ta' Malta f'post fejn tidher u għandu josserva r-regoli dwar l-ilbies mahruġa mill-istess Awtorita.

(8) *Car park attendant* ikun awtorizzat li jaħdem biss fil-parkeġgi tal-karozzi murija fil-liċenzja tieghu. Għandu jkun f'dak il-parkegg jew parkeġġi tal-karozzi matul il-ħin muri fil-liċenzja tiegħu. Il-persuna li għandha l-licenzja hija responsabbi għat-tindif tal-post tal-parkegg meta hija tkun xogħol.

(9) L-Awtorita' dwar it-Trasport ta' Malta għandha twaqqaqaf sinjal li jidher fid-dħul tal-parkegg tal-karozzi skedat fejn tindika li:

- (a) l-post huwa parkegg tal-karozzi skedat; u
- (b) l-hinijiet li matulhom ikun hemm l-*car park attendant*.

(10) *Car park attendant* għandu jkollu permess li jżomm kull gratifikazzjoni li jista' jirċievi mingħand sewwieqa li jużaw l-parkegg tal-karozzi.

(11) *Car park attendant* għandu juža l-kura u d-diligenza kollha sabiex jiżgura d-dħul, l-parkegg u l-ħruġ ordinat tal-vetturi f'kull

parkegg tal-karozzi li għalihi responsabbli u li ma jippermettix serq jew hsara lil dawk l-vetturi. Huwa għandu jniżżeł bil-miktub n-numru ta' registrazzjoni ta' kull vettura involuta f'kollizjoni jew incident iehor f'dak il-parkegg tal-karozzi u jirraporta l-partikolaritajiet lill-Pulizija.

(12) Kull persuna li tagħmel użu ta' parkegg tal-karozzi għandha thares is-sinjal jew istruzzjonijiet leġġitmi *tal-car park attendant* dwar id-dħul, l-parkegg u l-ħruġ tal-karozza f'dak il-parkegg tal-karozzi. Ebda persuna ma għandha tipparkja vettura eqreb minn 750mm min-naha ta' vettura oħra u *l-car park attendants* għandhom jiżguraw illi din d-disposizzjoni tīgi osservata mis-sewwieqa.

(13) L-Awtorita' dwar it-Trasport ta' Malta tista' tqiegħed ma' kull licenzja mahruġa jew imġedda skond dan ir-regolament kundizzjonijiet oħra li jidhrulha xierqa biex tīgi żgurata l-osservanza sewwa tad-dmirijiet ta' *car park attendant*.

(14) Bla hsara għal kull responsabbilta oħra ta' *car park attendant* skond id-disposizzjonijiet ta' dawn r-Regolamenti jew ta' xi ligi oħra, l-Awtorita' dwar it-Trasport ta' Malta tista', f'kull wieded mill-każzijiet li ġejjin, tissospendi għal dak iż-żmien li jidhrilha xieraq jew thassar l-licenzja ta' *car park attendant* jew tirrifjuta t-tigħid tagħha:

- (a) jekk tkun sodisfatta li l-persuna li għandha l-licenzja m'ghadhiex kapaċi taqdi dmirijiet;
- (b) jekk l-persuna li għandha l-licenzja tinstab hatja ta' rejat;
- (c) jekk jiġi pruvat għas-sodisfazzjon ta' l-Awtorita' dwar it-Trasport ta' Malta illi l-persuna li għandha l-licenzja ġabet ruħha hażin jew b'mod li mhux xieraq waqt li kienet qed taqdi dmirijietha jew li kisret xi wahda mid-disposizzjonijiet ta' dan r-regolament jew xi wahda mill-kundizzjonijiet li jkun hemm għal-licenzja;
- (d) jekk l-persuna li għandha l-licenzja naqse li tissodisfa kull responsabbilta civili li jkun dahal ghaliha favur xi hadd li jkun uža l-parkegg tal-karozzi taht r-responsabbilita tieghu.

(15) Meta l-Awtorita' dwar it-Trasport ta' Malta tkun qed taqdi l-funzjonijiet tagħha skond dan ir-regolament, hija ma tirrendix lill-Gvern suġġett għal xi responsabbilta dwar xi telf ta', jew hsara lil xi vettura jew oġġetti li jinsabu fiha jew tgħamir tagħha jew dannu ikkaġunat b'xi mod iehor, f'post ta' parkegg.

(16) (a) Fejn *tag* ta' identifikazzjoni mahruġa taħt dawn r-regolamenti giet mitlu fuu jew misruqa, jew *l-car park attendant*

m'ghadux b'xi mod iehor f'pussess ta' din *it-tag, l-car park attendant* għandu jinnotifika lill-Awtorita' dwar it-Trasport ta' Malta fi żmien hamest ijiem mid-data meta jsir jaf b'dan l-fatt.

(b) L-Awtorita' dwar it-Trasport ta' Malta għandha, fi żmien ġħaxart ijiem mill-irċevuta ta' din n-notifikazzjoni, toħroġ *tag doppja* biex tiehu post l-original. L-miżata għal din *it-tag doppja* għandha tkun ta' Lm5.

(17) (a) L-Awtorita' dwar it-Trasport ta' Malta għandha iżżomm Reġistru tal-*car park attendants* kollha li huma illiċenzjati.

(b) Ir-Reġistru għandu juri l-isem, indirizz residenzjali u numru tal-karta tal-identita ta' kull *car park attendant* illiċenzjat u n-numru tal-licenzja tiegħu, l-post fejn qiegħed l-post ta' parkegg li huwa illiċenzjat sabiex jopera fis-hu u l-hin li fis-hu awtorizzat sabiex jopera f'dak il-post ta' parkegg.

(c) Ir-Reġistru għandu jkun disponibbli għall-ispezzjoni mill-pubbliku.”

Emenda tar-regolament 122 tar-regolamenti principali 8. Fir-regolament 122 tar-regolamenti principali, l-kliem “L-Kummissarju tal-Pulizija għandu s-setgħa li jiffissa postijiet ta' parkegg”, għandu jkun mibdul bil-kliem “L-Awtorita’ dwar it-Trasport ta’ Malta għandu jkollha s-setgħa li tiffissa postijiet ta' parkegg” u l-kliem “L-Kummissarju tal-Pulizija għandu s-setgħa li jgħarraf liema huma l-postijiet ta' parkegg” għandhom jiġi mibdula bil-kliem “L-Awtorita’ dwar it-Trasport ta’ Malta għandu jkollha s-setgħa li tħarraf liema huma l-postijiet ta' parkegg” u l-kliem “u jista’ hekk jirriżvera spazju ta' parkegg kontinwu skond il-parir tal-Bord għall-Kontroll tat-Traffiku.” għandhom ikunu mibdula bis-sentenza li ġejja: - “Iżda l-Awtorita’ dwar it-Trasport ta’ Malta tista’ tipprovd għal postijiet ta' parkegg kontinwu.”.

**MALTA TRANSPORT AUTHORITY ACT  
(CAP. 332)**

**Motor Vehicles (Amendment) Regulations, 2003**

IN exercise of the powers conferred by article 54 of the Traffic Regulation Ordinance, and by article 27 of the Malta Transport Authority Act, the Minister for Transport and Communications has made the following regulations:-

- (d) sub-paragraph (b) of paragraph (1) shall be deleted and sub-paragraph (a) of paragraph (1), as amended, shall be renumbered as paragraph (1);
- (e) in sub-paragraph (b) of paragraph (2) as amended, the words “Public Transport” shall be deleted and for the words “to produce to the Authority such information and documents as the Authority may direct.” there shall be substituted the words “to produce to the Malta Transport Authority such information and documents as the said Authority may direct.”;
- (f) in sub-paragraph (b) of paragraph (4) as amended for the words “an initial examination by the Police or the Authority examiners” there shall be substituted the words “an initial examination by the Malta Transport Authority examiners”;
- (g) in sub-paragraphs (c), (d) and (e) of paragraph (4) as amended, the words “or the Authority, as the case may be,” shall be deleted;
- (h) in sub-paragraph (e) of paragraph (4), as amended, the words “or the Authority” shall be deleted;
- (i) paragraph (3) and the amended paragraph (4) shall be renumbered as (4) and (5) respectively;
- (j) immediately after the amended paragraph (2) there shall be inserted the following new paragraph –

“(3) In the case of second hand M1 motor vehicles and motor cycles that were ordered on or after the first of April 2003, the owner or importer shall, *inter alia*, provide the Malta Transport Authority, prior to importation, a single vehicle type approval certificate based on standards established by the Malta Transport Authority and issued by an internationally recognized inspecting agency chosen by the owner or importer and approved by the Malta Transport Authority for the purpose.”.

Amendment of 4.  
regulation 18 of  
the principal  
regulations

Regulation 18 of the principal regulations shall be amended as follows –

- (a) in paragraphs (1) and (2) for the words “Commissioner of Police” there shall be substituted the words “Malta Transport Authority”;
- (b) in paragraph (4) for the words “at all times covered by a licence issued by the said Commissioner:” there shall be substituted the words “at all times covered by a licence

issued by the said Authority” and for the words “informs in writing the said Commissioner” there shall be substituted the words “informs in writing the said Authority” and for the words “the said owner will hand over to the said Commissioner” there shall be substituted the words “the said owner will hand over to the said Authority”;

- (c) in paragraph (5) for the words “the Commissioner of Police may move such vehicle and place it at the Police garage at the expense of its owner.” there shall be substituted the words “the Commissioner of Police or the Malta Transport Authority, as the case may be, may move such vehicle and place it at the Police garage or at any other secure premises at the expense of its owner.”;
  - (d) paragraph (6) shall be deleted.
5. In regulation 19 of the principal regulations for the words “by the Commissioner of Police or the Authority,” there shall be substituted the words “by the Malta Transport Authority” and for the words “by the said Commissioner or by the Authority” there shall be substituted the words “by the said Authority”. Amendment of regulation 19 of the principal regulations.
6. In regulation 20 of the principal regulations for the words “the Public Transport Authority Act.” there shall be substituted the words “the Malta Transport Authority Act.”. Amendment of regulation 20 of the principal regulations
7. Regulation 65 of the principal regulations shall be deleted and shall be substituted with the following new regulation - Substitution of regulation 65 of the principal regulations
- “65. (1) No person shall act as a car park attendant without a licence issued by the Malta Transport Authority.

(2) An application for a licence under this regulation shall be made on the prescribed form. The completed form, accompanied by two recent passport size photographs of the applicant, shall be deposited or sent to the offices of the Malta Transport Authority.

(3) New licences will be issued by the Malta Transport Authority in accordance with the priority order that the said Authority received them.

(4) A licence issued under this regulation shall be:-

- (a) personal and non-transferable;
- (b) applicable only for the times and the scheduled car park that the car park attendant is licensed to attend;
- (c) valid up to the 31<sup>st</sup> day of December of the year during

which it is issued, but may thereafter be renewed from year to year; and

- (d) subject to the payment of Lm5 payable upon the issue of the licence and each year following the year in which the licence was issued.

The Malta Transport Authority shall also provide licensed car park attendants with a photocard tag indicating the name, identity document number and the licence number, the car park he is licensed to attend and the times during which he can act as a car park attendant in that car park.

(5) No licensee shall act as a car park attendant unless the licence fee payable every year or for any period as specified has been paid.

(6) The Malta Transport Authority shall not issue to any person a licence under this regulation unless it is satisfied that such person is of good character and is fit to carry out his duties.

(7) A car park attendant shall, while on duty, wear the photocard tag issued by the Malta Transport Authority in a conspicuous place and shall observe the dress code set out by the said Authority.

(8) A car park attendant shall be authorised to operate only in the car park or parks indicated in his licence. He shall attend at such car park or parks during the times indicated in his licence. The licensee is responsible for the cleaning of the parking site during the time he is operating.

(9) The Malta Transport Authority shall put up a conspicuous sign at the entrance of each scheduled car park indicating that:

(a) the place is a scheduled car park; and

(b) the times during which a car park attendant shall be in attendance.

(10) A car park attendant shall be permitted to keep any gratuities he may receive from motorists using the car park.

(11) A car park attendant shall use all care and diligence to ensure the orderly entry, parking and exit of vehicles in any car park under his charge, and to prevent all thefts from, or damage to, such vehicles. He shall note down in writing the registration number of any vehicle involved in a collision or other incident at such car park, and report the particulars to the Police.

(12) Every person making use of a car park shall comply with the lawful signals or instructions of the car park attendant in connection with the entry, parking and exit of the vehicle in or

from such car park. No person shall park a vehicle nearer than 750mm to the side of another vehicle and car park attendants shall ensure that this provision is complied with by drivers.

(13) The Malta Transport Authority may attach to any licence issued or renewed under this regulation such other conditions, as it may deem fit, to ensure the proper execution of the duties of a car park attendant.

(14) Without prejudice to any other liability incurred by a car park attendant under the provisions of these Regulations or of any other law, the Malta Transport Authority may, in any of the following cases, suspend for such time as it may deem fit or cancel the licence of a car park attendant or refuse its renewal:

- (a) if it is satisfied that the licensee is no longer fit to carry out his duties;
- (b) if the licensee is convicted of a crime;
- (c) if the licensee is proved to the Malta Transport Authority's satisfaction to have misbehaved or misconducted himself while on duty or to have infringed any of the provisions of this regulation, or any of the conditions attached to his licence;
- (d) if the licensee has failed to meet any civil liability incurred by him towards any user of the car park under his charge.

(15) The exercise by the Malta Transport Authority of its functions under this regulation shall not render the Government subject to any liability in respect of the loss of, or damage to any vehicle, or its contents or fittings, in a parking place or in any other respect.

(16) (a) Where a photocard tag issued under these regulations has been lost or stolen, or the car park attendant is otherwise no longer in possession of such tag, the car park attendant shall notify the Malta Transport Authority within five days from the date on which he becomes aware of such event.

(b) The Malta Transport Authority shall, within ten days from the receipt of such notification, issue a duplicate tag in replacement of the original. The fee for such replacement tag shall be of Lm5.

(17) (a) The Malta Transport Authority shall keep a Register of all licensed car park attendants.

(b) The Register shall show the name, residential address and identity document number of each licensed car park attendant and his licence number, the location of the car

park he is licensed to operate in and the time he is licensed to operate in that car park.

(c) The Register shall be available for public inspection."

In regulation 122 of the principal regulations, for the words "The Commissioner of Police shall have power to fix parking places", there shall be substituted the words "The Malta Transport Authority shall have power to fix parking places" and for the words "The Commissioner of Police shall be empowered to indicate parking places" there shall be substituted the words "The Malta Transport Authority shall be empowered to indicate parking places" and for the words "and may so reserve parking spaces continuously on the advice of the Traffic Control Board." there shall be substituted the following sentence:- "Provided that the Malta Transport Authority may provide for continuous parking spaces.".
